Senior Portrait Contract With Activity & Dance Coverage

Sunset Photography makes the following offer to Jackson County School District, which in turn grants Sunset Photography the *exclusive* rights to the school photography services listed below for the graduating class of 2013.

A. The following senior portrait services will be made available to the High School:

- One digital image of each senior will be supplied for the yearbook at no charge.
- For the month of June 2013 the class of 2014 can have their Yearbook photo taken at the studio for \$10.00, However, after the month of June 2013 their will be a \$20.00 sitting fee for students coming to the studio.
- One day of photography at the school in May, of 2013 will be allocated to the school for the 2014 seniors to have their yearbook photos taken. This will be done for a \$10.00 retouch charge to the student. However there will be a \$20.00 charge for any retakes.
- Sunset Photography will schedule one day of photography for the school as the Yearbook gets closer to its deadline. This date will be agreed upon by Sunset Photography and the School at a later date. There will be a \$20.00 sitting fee per student for this session.
- One full-page ad will be purchased in the High School yearbook.

- Each of the following events shall be covered by Sunset Photography free of charge. Images of the following events shall be supplied at no charge to the Yearbook Staff for publication in the school's yearbook:
 - Homecoming Football Game
 - Homecoming maids in studio or at school
 - Annual Staff in studio or at school
 - Who's Who in studio, on location or at school
 - Senior Courtyard Picture
 - Prom court Basket Ball and Football
 - Baseball
 - Track and Cross Country
 - Any scheduled event the school and Sunset Photography agree upon.

B. The following list of events will be exclusive to Sunset Photography

All teams and groups are to be shot *exclusively* by Sunset Photography. Packages will be offered according to the event.

All Package prices are supplied to the school also online and upon request. Money envelopes for the sports teams and advertising material for each event will be supplied by Sunset Photography at no charge:

- Homecoming Dance
- Junior/Senior Prom
- Sports Teams including Football, Soccer, Band, Basketball, Volleyball, Baseball, Golf, and all other teams
- All Dances, Balls, and Pageants
- Graduation Pictures on Stage
- Coaches will receive a complimentary team picture.

C. Sunset Photography will supply five flash drives and three compact flash cards to the school for use of the Yearbook Staff.

D. Sunset Photography will create a 24x30 Senior Class Composite at no charge to the school.

E. Teachers will receive a 20% discount on any picture package when

properly noted on package envelopes or at the time of their purchase.

F. Scholarship awards and Donations.

- A \$10.00 donation per senior photographed by Sunset Photography will be placed into a scholarship fund represented by Sunset Photography.
- 10% of all dances will be donated to its perspective group or organization.

G. Scheduling of events

- All photography shoots must be scheduled at least two weeks in advance to ensure a photographer is available for that day and time. Special cases and emergencies will be handled based on availability.

We strongly encourage the school to dissuade teachers and students from soliciting students to have only their yearbook portrait taken with Sunset Photography, and their senior portraits taken by an employee of the school system or a member of the student body.

We find in many cases these services are performed illegally since the providers are neither registered with the IRS nor the State of Mississippi. We also feel that any solicitation within the school grounds, be it from the high school or elementary schools, represents a conflict of interest for both parties.
